The NRPFSS targets Nebraska students in grades 8, 10, and 12 with a goal of providing schools and communities with local-level data. As a result, the NRPFSS is implemented as a census survey, meaning that every public and non-public school with an eligible grade can choose to participate.

The 2018 NRPFSS was administered starting in August 2018 and concluding during March 2019.

The NRPFSS is a self-administered survey available as paper-pencil and web-based, and administered within the classroom. In 2018, the survey was offered in English and Spanish.
